### **1. Statutory tuition fee**

You will pay the statutory or statutory+ tuition fee to attend a study programme at Breda University of Applied Sciences if you comply with all of the following conditions:

- You satisfy the nationality requirement. This means that you have the nationality of a country that is part of the European Economic Area (EEA) or that you have the Surinamese or Swiss nationality. The European Economic Area (EEA) includes all European Union (EU) countries, with the addition of Liechtenstein, Norway and Iceland.

EU countries: Belgium, Bulgaria, Cyprus, Denmark, Germany, Estonia, Finland, France, Greece, Hungary, Ireland, Italy, Croatia, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Spain, Czech Republic, Sweden.

You also satisfy the nationality requirement if you have a Dutch residence permit which entitles you to a Dutch student grant:

**and**

- You do not already possess a bachelor's degree upon the start of the academic year of your bachelor's programme, and you do not already have a master's degree upon the start of the academic year of your master's programme from a government-funded programme in the Netherlands.
- Students who are attending a bachelor's programme and who already completed a bachelor's degree (or a degree equivalent to bachelor's level) after 1 August 1991 in the Netherlands, will pay the institution tuition fee. Students who are attending a master's programme (except for the master Imagineering) and who already completed a master's degree (or a degree equivalent to master's level) after 1 August 1991 in the Netherlands, will pay the institution tuition fee.

An exception to this rule is applicable to students who already started on their second course of study before having completed their first course of study. They will be allowed to continue to study at the lower statutory tuition fee, until a degree is obtained;

**and**

- You are enrolled in a government-funded programme at Breda University of Applied Sciences.

If you do not comply with all of the aforementioned conditions, you will have to pay the institution tuition fee.

If at some point during the academic year you cease to comply with the conditions regarding nationality, Breda University of Applied Sciences will charge you the higher institution tuition fee retrospectively.

Every year the government determines the statutory tuition fees. The amount is equal for all educational institutions. The statutory fee is indexed annually.

**2. Higher statutory tuition fee for Creative Business, Creative Media and Game Technologies and Applied Data Science and Artificial Intelligence**

Within the framework of the 'special feature of small-scale intensive education' Breda University of Applied Sciences is allowed to select 100% of the students for the degree programme in Creative Business, Creative Media and Game Technologies and Applied Data Science & Artificial Intelligence in combination with an increase of statutory tuition fees as stated in the Tuition Fee Regulations.

**3. Pre-master's fee**

- a. A student who attends a pre-master's track and is only enrolled in a programme for that purpose will not pay tuition fees but a pre-master's fee during the period of the pre-master's track. This student will pay a fee equal to the statutory tuition fee if this student meets the nationality requirement. This means that the student has the nationality of a country participating in the European Economic Area (EEA) or Surinamese or Swiss nationality. The European Economic Area (EEA) includes all European Union (EU) countries, supplemented by Liechtenstein, Norway and Iceland.

EU countries: Belgium, Bulgaria, Cyprus, Denmark, Germany, Estonia, Finland, France, Greece, Hungary, Ireland, Italy, Croatia, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Spain, Czech Republic, Sweden.

If the student does not meet one of the above-mentioned nationality requirements, a fee equivalent to the institutional tuition fee will apply.

- b. A student taking a pre-master's degree, while that student is taking a higher education programme for which statutory tuition fees are due, will be exempted from paying a fee for this pre-master's degree.
- c. If a student only pays statutory tuition fees for part of the academic year, the exemption from paying the pre-master's fee only applies to the period in which the student owes statutory tuition fees. For the remaining months of the academic year, this student will be required to pay a proportional part of the pre-master's fee.
- d. In case of disenrollment at some point during the academic year, there will be no refund of the pre-master's fee.

- e. The fee will be paid as a lump sum or in equal instalments in accordance with Article 10 (Administration costs).
- f. The amount of the pre-master's fee for a subsequent academic year will be determined on the basis of the remaining study credits to be obtained as at 1 September (reference date) of that academic year.
- g. The pre-master's student, who takes a pre-master's degree and is only enrolled in a programme for that purpose, may only take the courses that are part of the pre-master's track. If this pre-master's student takes additional courses, then a regular enrolment is also required with associated tuition fees.

#### **4. Master Sustainable Outdoor Hospitality Management tuition fee**

The payment of BUas statutory tuition for the Sustainable Outdoor Hospitality Management master's degree is paid in advance at BUas. This is the tuition fee for two years of study at BUas. During the programme, the remaining tuition is charged to the University of Rijeka in Croatia and the University of Girona in Spain. Because of the structure of the program, a person is not entitled to a refund of tuition fees paid to BUas if the enrolment is terminated after the end of semester 1. In case of premature termination of enrolment during semester 1, the student will be entitled to a refund of the tuition fee paid to BUas for the months during which he/she is no longer enrolled.

Fees for Croatia and Spain for the 2025-2026 academic year have not been determined yet. For the 2024-2025 academic year, the amounts below apply.

The total cost for this two-year master's program is ± €10,500 for EU students and ± €26,000 for NON-EU students. In the academic year 2024-2025, the statutory tuition fee for master's programs in the Netherlands is €2,530 for EU students and €15,200 for NON-EU students. This includes enrollment at BUas for 2 years. The remaining tuition fee of ± €8,000 for EU students and ± €11,000 for NON EU for Croatia and Spain will be determined and charged during the academic year.

#### **5. Institution tuition fee**

The institution fees for the bachelor- and master programmes are based on the statutory fees plus the amount of government funding per student.

Within the framework of the 'special feature of small-scale intensive education' Breda University of Applied Sciences is allowed to apply an increase to the institution fee for Creative Business, Creative Media and Game Technologies and Applied Data Science & Artificial Intelligence. This additional fee applies to students starting in or after the 2023-2024 academic year.

The institution fee for the academic bachelor in Tourism (joint degree) of Breda University of Applied Sciences has been made equal to the institution tuition fee of Wageningen University.

#### **6. Extension fee for delayed completion of Imagineering master's degree**

If a student is unable to complete his or her master's degree within the specified duration of the course, the student may apply for an extension of his/her enrolment period with the management team of the course programme. An extension typically comprises one additional graduation opportunity. A fee will be charged for an extension, as stated in the Tuition Fee Regulations.

#### **7. Reduction or exemption of tuition fees for second, simultaneous, enrolment**

While attending a bachelor's or master's degree programme you can take courses from another study programme or follow a complete second study programme (at the same or another funded institution for higher education in the Netherlands), as long as you have not yet completed a degree.

You will not be charged an additional tuition fee on top of the statutory fee already paid for the first bachelor's, Ad or master's programme.

##### *Exemption on account of enrolment with other institution*

Exemption from or reduction on account of enrolment with another institution only applies if statutory tuition fees are paid, not if institution tuition fees are paid.

##### *Exemption on account of second enrolment with Breda University of Applied Sciences*

Students enrolled in more than one study programme at Breda University of Applied Sciences, will only pay the tuition fee once. This applies to the statutory fee as well as the institution fee. In this occurrence, the highest tuition fee will be charged.

This rule applies to bachelor's, associate degree and master's programmes. This rule does not apply to the post-initial master's programme in Imagineering.

**8. Refund of tuition fee**

In the case of premature termination of enrolment in a study programme for which the statutory tuition fee is due, the student will be entitled to a refund of the tuition fee for the months during which he/she is no longer enrolled. Tuition fee refunds will not be granted if the date of the termination of enrolment is 30 June or later.

Breda University of Applied Sciences also applies this refund scheme for the institution tuition fees for bachelor's or associate degree enrolment and for enrolment in the master's programmes.

Students of post-initial master's programmes in Imagineering are not entitled to a refund.

Different refund regulations apply to the Sustainable Outdoor Hospitality Management master's program, see No. 4.

**9. Exam fee for 'extraneus' students**

The exam fee for 'extraneus' students will be determined by the Executive Board of Breda University of Applied Sciences on a case-by-case basis.

**10. Administration costs**

The tuition fee can be paid in its entirety or in multiple instalments. If the fee is paid in instalments, students will be charged a one-off administrative fee of €24.

**11. Reservation**

The tuition fee stated on the digital direct debit form in Studielink is subject to change. A change may be applied if, after verification, it turns out that you fall into a different category than initially assumed.

**12. Unforeseen cases**

Cases not provided for by these regulations will be handled by the Executive Board.
